On 30/1/2020, comrades Dimitra Valavani, Konstantina Athanasopoulou and Giannis Michailidis were arrested in a stolen car in Agia Paraskevi following an anti-terrorist operation.

Weapons were found inside the car, which was driven by Giannis Michailidis. He and Konstantina Athanasopoulou were wanted, the first as fugitive from the rural prisons of Tirintha and for participation in the E.A. , R.O. REVOLUTIONARY STRUGGLE the second for bank robbery.

All three comrades are being tried on May 31 in the courts in Athens , Loukareos Street, room D80ST, 2nd floor.

The robbery of Piraeus Bank in Achaia on 29/8/2019 has been added to the case, as well as holding a police officer hostage in Halkidiki on 30/12/2019.

All three are also accused of forming a criminal organization.

### **A first statement from comrades Valavani, Athanasopoulou and Michailidis 2/3/20**

Difficult is the moment when freedom is lost. Especially when it had been won in adverse conditions. The situation gets worse if we consider that the blow we received on a material level has even stronger symbolic implications. Our cinematic arrest was followed by similar media propaganda, our graphic tour with bulletproof vests and the usual judicial management to find ourselves once again with an overblown set of charges, elements that form an extension of the handcuffs and weapons of the uniformed assassins.

A look at the wider social situation around us which is changing at a rapid pace so that we can slip away from our own microcosm a little.

From the magnitude of the workers' exploitation and abolishing of labour rights to the stranglehold of animals in meat production units. From the intensive repression against protests and the purchase of state-of-the-art equipment from anti-terrorist services around the world, to deforestation and the disappearance of wildlife. From the financial exclusion of a growing social segment to the violent marginalization of most of the earth's population. To the murders of the poor, the excluded, of all who are leftovers in the world of the mighty. From the provocative economic and business elite to the peoples being bombed, shot and uprooted. Where the interests of the powerful mean death, danger or a life drowned in submission. Nature, animals and humans mean nothing more than units generating profits and wealth. These and many others led us to choose the anarchist struggle, a choice that challenges the existing social order. Our initial focus is on creating authentic and sincere relations, while at the same time there is the lasting need of our participation in the multiform struggle. After all, the anarchist struggle does not differentiate its means or support a hierarchy of forms of struggle. It is imperative and adjusts according to the conditions of each era, placing its bet on collectivization and diffusion on the social fabric.

All the time until our arrest – though not all of us were under the same ‘legal’ conditions – we realized that the antiterrorist forces were tightening their grip around people close to us with the known-unknown methods of surveillance, the open secret that officially the Greek State denies exists. No matter how much they scream about the legitimacy they are supposedly defending, they invade every aspect of our families and friends’ personal life in the most outrageous and depraved way. Telephone surveillance, 24-hour physical surveillance behind every step of our people, tracking devices, people waiting in cars outside houses. No matter how they try to convince of the supposed legitimacy of their ways, the Counterterrorism Service uses illegal practices.

On the morning of Monday, January 29th we set out for the car which had been stolen 2 days before and with which there had been no contact from the time of theft to the aforementioned cursed day. From Vyrona’s quiet streets we moved to the mountain (Ymittos) where it was obvious that we were not being followed or following another vehicle on the road and on dirt tracks, indicating that the monitoring was probably electronic. When we came out of the mountain to Agia Paraskevi there was unnatural movement around us. We soon realized that we had been ambushed by anti-terrorist units when we were surrounded on all sides by many cars and motorcycles in a coordinated way. Our conclusion is that the police, suspecting that we might use that particular car model, as soon as they were informed of the theft of this type of car were mobilized in a tracking process scanning specific areas where for reasons we are not sure they thought it might be parked.

But who are they who, according to their statements “considering the conditions”, decided to intervene at noon in one

of the busiest spots in Athens? Who are they who pulled out guns at midday in the middle of a street with pedestrians and cars? Who are they in the end, with the responsibility of the Minister of Security

Dimitra Valavani is free! from 30th of July 2021 she walked out to the streets as she had already been in prison from January 31.01.2020

Konstantina Athanasopoulou had been on the run since she was released on bail for activities related to the Revolutionary Struggle organization.

She was sentenced in absentia in 2019 to 35 years and 6 months. Kostantina is still in prison and the appeal court trial of the Revolutionary Struggle organization continues this month, July 2021 also the 2 members of the Revolutionary struggle Roupa Panagiota (Pola) and nikos Maziotis, and one person charalampidis x.

Michalis Chrysochoidis and the commander of the “anti” terrorist agency Lefteris Hardalias, who risked setting up and validating an

operation in the middle of the road IGNORING THE SAFETY OF CITIZENS to arrest two wanted persons? That’s how they value the importance of human life and the safety of citizens passing by? According to the thirst for results? Children, schools, people on balconies, random drivers are automatically of no importance. Only work to get results at all costs. They never asked themselves who was really endangering and terrorizing society as a whole, two wanted people in a car or the risky intervention of armed police officers in hoods in the middle of the road?

Of course this is not the first time that the opportunistic minister has chosen to risk or even sacrifice the lives of citizens. In his previous administration a 25-year-old Albanian worker, Nikola Todi was executed in a police operation by cops in Vyronas that considered him to be one of some hunted escapees. Chrysochoidis covered the murder politically, calling it the successful arrest of 2 “dangerous criminals” while still today all the media refer to a dead body found amidst an exchange of gunshots.

What follows the arrest of anarchists is more or less known. Violent depraved treatment, isolation, etc. We don’t intend to give more details in describing what followed so as to not help spread the terror message that the repressive mechanism of the State emits. But we have to make known that during the violent taking of DNA samples from the two comrades who clearly did not accept this process, an anti-terrorist bully hit comrade Valavani’s head against the wall despite being informed of her recent surgery to the head. Then, after they got her genetic material both with the swab as well as from the spits in their faces, she was forbidden to contact the doctor who had operated on her and they took her to a hospital where she had examinations irrelevant to her case. They acted as the law stipulated, as the lawfully positioned commander of the anti-terror-

ist Lefteris Chardalias told us in person. It is worth remembering that his predecessor is now wanted for arms smuggling through this otherwise law-abiding service. We assume the modern Iaverides are searching for him too as intensively as they were us but he probably has ghost-like capabilities. We're also sure they'll spend as much as with our own research on discovering the gold smuggling ring his service officers are involved in as also for their dozens of "purely legal" services for prominent businessmen. So these people are our persecutors and that is their ilk.

The prominent role in the repression of dangerous ideas and actions in our wonderful media democracy goes to the ideological mechanism of the media of mass deception. Who with its famous tricks plays the dominant role in altering reality. Obvious example, the official house of our comrade gets baptized a hideout by the canal junta without actually finding anything illegal within it. Their focus is by no means accidental. Having already secured many years of imprisonment of two of us with heavy penalties, with comrade Michailidis 6.5 years in prison and comrade Athanasopoulou already 18 months in jail, sentenced to 35 years in prison, they are trying to upgrade the charges of comrade Valavani for which they did not have some heavy penalty ready, thus making obvious their will to avenge her attitude, that of the solidarity she showed.

Really who are all these excellent owners of all of these television and publishing groups that through their employees effortlessly throw their poison against us. The reality re their ilk is devastating. Smugglers, drug dealers and murderers.

Representatives of the propaganda instruments of the regime dare to call us terrorists, a word all regimes slanderously use worldwide against rebels – insurrectionaries from the time of the French Revolution onwards.

Let us remind them that bourgeois democracy used the method of

And finally, I am again accusing of robbery any policeman who, by his profession, grabs people, tortures them and leads them in shackles to the dungeons of the State, where whole lives are destroyed.

For those who are blamed for not coming to terms with the vast slaughterhouse that States have turned the earth into, for seeking ways to live outside the condition of generalized captivity, there are moments of struggle like this that return the blame to their persecutors and shatter the projected image of inverted reality that has been imposed as the only truth.

tion on the charges against me personally. As for the charge of escape, I am honoured to have broken the bonds of my captivity in a radical way. However, I must mention that my escape, organized in less than 12 hours, was a response to a fabricated case of prison strike, without any proof or testimony, which would have cut my furloughs and terminated the computation of the beneficial sentence in the rural prison, resulting in an increase of my stay in prison by 1 year, something I was not willing to accept passively, so I chose instead of humiliation to live a life of persecution.

Regarding the accusation of criminal organization I have already given my position. Furthermore, I will say that a criminal organization with differentiated roles and a hierarchical structure is the police-judicial complex that tortures and imprisons thousands of people to impose the monopoly of State violence.

If heavy arms trafficking is what is being sought, see the transnational trafficking of weapons intended for the slaughter of entire populations, in which the Greek State is actively involved. An example is the state-of-the-art rockets that Greece sold to Saudi Arabia, a country where raping underage girls is called legal marriage. Thus, rockets unloaded by the Greek State were used in the bombing of the poorest country in the world, Yemen, to destroy infrastructure and starve millions of people. Of course, no minister will be dragged to court. Mass murder and international trafficking in heavy weapons are perfectly legitimate activities. If, of course, I own 3 guns from decades past, they are called heavy weapons and I get hauled off to jail along with anyone who stands next to me. But that is the essence of laws, protecting the powerful from rebellion from the bottom of the social pyramid.

As for the accusation of theft, I throw it back to any bank whose nature of existence is the accumulation of wealth and the widening of social inequalities. Theft is the establishment of a bank, what I have done is to redistribute wealth.

terrorism against its rivals to establish its authority. Our life-attitude seeks to collectively defeat the fear that the State mechanism dispenses and overthrow this oligarchic regime calling itself democracy. We fight every day against State and capitalist terrorism. At the same time during the media management of our case sexist terms are clearly used, both undermining the stance and attitude of women and highlighting the patriarchal model of a male leader of a “criminal organization” that used women around it. This is more than offensive to our relations and stance in general.

The repressive operation that was carried out against us is not one isolated police operation but the persistence of the State in an attempt to exterminate and crush all forms of resistance, every rebellious heart beating in freedom. It comes as a moment of the State’s absolute resolve against the evacuated squatters, the refugees in the concentration camps, broken heads at protests, sexist violence against women in Exarchia, restructuring of the legal arsenal of the State. Some final conclusions: Sure it was worth it. Every free day expropriated from prison slavery is priceless.

Confrontation with a mechanism that is becoming more and more powerful is getting harder and harder to uphold. Protection is also required in matters where until recently we did not imagine, while it is imperative that we don’t repeat ourselves and are insightful.

Luck plays a decisive role but the odds were against us. At this last point, it is worth pointing out that there is so much at stake here. Every repressive operation sends a message of power. This message is intended to terrorize people who actively resist the State machine. This has the effect of reducing the actions and subjects that act, which results in focusing the mechanisms on the remaining few. Exactly this is asymmetrically increasing their chances against us. That is why it is necessary to defeat fear, to re-popularize direct action. To not give up the street, to not give up the hostilities with the State and capital.



Solidarity finds meaning through the development of multiform subversive action.

Let us oppose their upcoming trial-parodies, on the overloaded charges, on the anti-terrorist 's scenarios-fiascos.

STRUGGLE WITH NO RETREAT UNTIL TOTAL LIBERATION

by cops**

Over the last year, more and more stories have reached the public about isolated moments of a continuous phenomenon which is as old as the existence of the state and authority. The phenomenon of police brutality.

From the murders of Afro-Americans in the USA, the murders in Myanmar after the coup, the riots in Paris after the voting of new laws in favour of cops, the murder of a 'suspect' in Albania, the fascist practices in Turkey, to Greece with the countless beatings of demonstrators and citizens, the vengeful transfers of prisoners, the continuous tortures in the Police Headquarters of Athens (Gada) and in the Police stations, the rapes and not only of refugees in the Deportation and Transfer Centre of Petrou Ralli, and many more incidents among which I can't forget the torture of my comrades in Police stations, their beatings in demonstrations, and of course the violent treatment I faced from the cops of the Counter-Terrorism Unit when they attempted to take a DNA sample from me. After our arrests on Jan. 29 2020, while we were detained on the 12th floor of

at us, we had no choice but to surrender or die. However, our arrest was met with vindictive brutality on their part, even tearing my clothes. Their claims of resistance from us, who were outnumbered and caught by surprise, are ridiculous to say the least. The only thing that comes out of this ridiculousness is the tendency of the police to inflate the files with false facts.

The first thing I said, when the tantrum was over and I was loaded backwards into the police car, was that they should have informed their superiors that Dimitra had tenderness in her head due to a recent operation, so that she would not be beaten. Which, of course, did not stop the security guards from slamming her head against the wall while she was restrained, to forcibly extract genetic material from her. They showed how outraged they are that people are standing up to them with dignity and not cooperating in the application of biometric totalitarianism.

This concludes the account of the events that led to our arrest, as the rest is well known. As a result of this succession of events, my partner has been in jail for 16 months now, accused of charges such as membership of a criminal organization and possession of heavy weapons. In a steamroller logic aimed at isolating the wanted anarchists, my own weapons, which I had on me and concealed, are automatically considered to be my comrade's weapons, while because 3 people were arrested together they are dubbed as a criminal organization even though there is not the slightest evidence linking these 3 people to illegal actions together, except for the fact of the arrest. With false accusations and implausible logical acrobatics my comrade was kept in prison, denied access to her graduate studies and her health was put at risk by the lack of medical care in Korydallos when she was taken to the hospital where the hospital doctor recommended a regular medical examination that was never carried out.

In concluding my statement, I take this opportunity to take a posi-



possible signs of police surveillance and decided that in order to escape arrest I had to leave my safe house (which was ultimately not located) and organize my escape from the cordon that had been set up. To do this I stole the RAV 4 and fabricated fake license plates. Late in the afternoon (before the day of the arrest), I emptied my bunker and loaded all useful things into the car I had stolen.

Then I informed Konstantina by phone and we made an appointment in Byron to go to the car and leave unannounced. Finally, I went to Dimitra's house in the morning by cab. I told the driver to wait outside and woke her up. I spoke to her briefly, whispering, as I was concerned that the house had been bugged. I told her to hurriedly gather the things she thought were necessary for us to leave. We left her house agitated and got into the cab, where again I could not explain what was going on as the driver was listening. When we arrived at Byron, Konstantina was already waiting for us there and we jumped into the RAV 4 so as not to be noticed by the surveillance team and escape the cordon. I asked Dimitra to drive because I was very tired from the night and the whole escape process. Once on the road, I gave a detailed report on what I had seen, what I had done and that I was carrying illegal items.

When we went up to Ymittos, where I had the illusion that we were not being watched, I changed the licence plates on the car and put on the fake ones I had prepared so that we could move around safely afterwards. At that point I contacted a friend of mine and asked him to look after Dimitra's house in case something happened to me. He, fearing that some outsider would get into trouble if we were arrested (as has happened many times before in similar situations), arranged for the house to be cleaned.

As soon as we came down the mountain and entered the urban area, we were attacked by the anti-terrorist police. The moment they pulled me out of the back seat where I was sitting, I dropped my Scorpion bag on the ground while my CZ pistol was in my pocket. Next to me was a locked bag with the Kalashnikov. With dozens of guns pointed

GADA, they asked me to give a DNA sample, which I refused, as I refused any type of cooperation. Since 2015, after the big hunger strike of prisoners, the prosecutor's order that forced the taking of DNA, changed to 'mandatory taking of DNA with respect to human dignity'.

A phrase totally unclear and pretentious as is the relation of cops with dignity. They either serve in counter-terrorism, in DRASI (motorbike cops) or MAT (riot cops), they are the ones that truly express authority, enforcing law, order, and security with any means necessary, satisfying at the same time their perversions and personal interests. In my case, their aim was to take a DNA sample from me, regardless of my refusal to give one, even though I told them about my serious health condition, a serious operation I had on my head.

The procedure of taking my DNA involved only men even though body-searches or any type of contact must be done by women. Realising what would follow, the only thing I could do was protect my head from the blows they were giving me. After they hit my head several times on the wall of the cell, they carried me to a room on the floor above. On a chair, with my hands tied behind my back, I had five men on top of me trying to restrain me, which wasn't difficult after all, since my upper body was tied. Two of them tried to restrain my legs, grabbing me by my thighs and opening them to the point I thought they would break. At the same time, two more men swore at me and pressed my head, putting their hands around my mouth in order to open it and get a DNA sample. Afterwards, they put me back in the cell the same way.

I immediately asked for communication with my doctor as I had severe pain in my head. They didn't allow it, not even with my lawyer, but after some time and after continuous pressure on my side, they took me to KAT hospital. Besides the special examinations I had, during which I was handcuffed, I had no communication with the doctor that operated on me and soon after they took

me back to GADA. After all this violent treatment, physical and verbal, in a reverse reality I am put on trial next Thursday April 1 at 9am in Evelpidon Court, accused of insulting and resisting the cops of the counter-terrorism. Being alone against five men who are opening and pulling your legs, who are hitting your head to open your mouth while shouting at you ‘we will fuck you, bitch’, doesn’t seem like ‘mandatory taking of DNA with respect to human dignity’ as they call it, but clear overuse of authority, enforcement of power in rape conditions.

I am put on trial, with one more case, while they took care that nothing would be monitored (there were no CCTV cameras around) of all the disgraceful things they did and continue to do. As always happens with cops that beat people, that torture and are put on suspension, that rape without being punished, that illegally watch our lives while the state and judges cover them, that break the very laws that they serve, and that kill but in the worst case get 13 years imprisonment then live their lives peacefully.

At the same time, people with lesser charges rot in prison, get tortured, get raped and killed.

independent judicial authorities were pressured to do the State’s bidding. The media propaganda had already shown the way with its gross lies, such as the fact that Dimitra’s house was labeled as a precedent for going into prison even though nothing illegal was found inside.

At this point I will begin a brief account of the events leading to our arrest to make it clear that the police narrative of a criminal organization has nothing to do with reality. Since my position is one of non-cooperation with the police and judicial authorities, I do not intend to provide information regarding my own actions and the acts for which I am individually charged. I will speak exclusively about the fact of the arrest, which is the only thing that relates me criminally to the two girls.

What you insultingly impute to me, an alleged criminal organization with hierarchical roles, of which I am even the head, is something that goes against my values, against the anarchist relations I try to promote and against my way of acting as a human being.

In fact, what connected us with Konstantina is that we were both on the run, while with Dimitra it was a relationship of deep companionship. Because of this relationship and her loyalty, which cannot be judged by any court of law, Dimitra was forced to endure long, persistent and disturbing surveillance by the anti-terrorist police to track me down. This led her to adapt her life to a counter-intelligence regime in order to meet me. She was even forced to travel under a false identity I gave her in order to escape the clutches of the anti-terrorist police every time she visited her mother in Berlin, who is there because she is receiving treatment. The house where Dimitra lived in Athens in order to visit her had to be checked for the possible presence of security guards. Since it was a legal house, which under normal circumstances would not be at risk of police intrusion, I had left some of my legal belongings there, such as clothes, shoes, notes, etc.

In the days leading up to our arrest, I had become aware of

what their choices imply. Or, what is worse, the time spent in prison depends most of the time on the pressures to which the judge is subjected or what benefits him financially. If you have the financial means to pay a reputable lawyer with the right connections and enough cash for bail, you won't rot in jail like the financially weak poor who fall into their clutches. If you are a cop and you shoot a child, your life sentence will be broken. If you are a prison officer and you beat up a prisoner, at most you will get a few months in jail. If you are an anarchist, an enemy of the regime, you will not get one day less. This profoundly classist and essentially unjust system has the audacity to call itself Justice.

So I am taking a stand against self-proclaimed Justice and its functionaries, who have treated me as an enemy. Until my previous arrest I chose to remain silent about the charges against me, which resulted in my being convicted even for things I had not done. However, in this case, the kidnapping of my partner and her prolonged confinement in prison is a permanent blackmail on my position and attitude. I no longer only have to consider the consequences of any choice she makes on myself personally, but also how it will reflect on her criminal treatment. Realizing that I am facing a kidnapping State, which keeps my partner in prison in order to take revenge and blackmail me, I have no choice but to constantly clarify what is her only involvement in the case, however little feel like giving explanations about my actions, my life or my relations to a State institution.

That is why I stated from the very first moment of the investigation process that my partner has no involvement in the robberies and thefts that I am charged with, while the weapons found on and near me were mine and under my exclusive control. The 2 girls sitting in the front seats did not even have eye contact with them as they were in zipped locked bags. However, whatever you say, the so-called fairness doctrine of proving guilt and not innocence did not apply in our case. Despite her and her mother's serious problems, she was remanded in custody and remains in jail to this day, as the otherwise

escape from prison, the choice of means, practical solidarity with the persecuted were, are and will remain an integral part of the history of the anarchist struggle.

We today experience history lived by those who took up arms against capitalist domination, those who gave life to anarchist ideas, those who acknowledge that the struggle for individual and collective liberation develops through the war against the state and capital.

We call for international expressions of solidarity such as the bannerdrop we did and the slogans that we wrote, so that through our mass presence we can send a message of solidarity to our imprisoned comrades. To stand by them in their effort to fight against any accusations. To raise our fists until the day they walk next to us. Until release...

## STATEMENT BY ANARCHIST GIANNIS MICHAILIDIS AT THE COURT FOR THE ARRESTS IN AGIA PARASKEVI AREA IN ATHENS

Once again I face a tribunal that I do not accept to judge my decisions and my actions. I have already stated my position on the State, capital, the established order of inequality and the widespread enslavement and exploitation of people and nature, the gradual transformation of the planet into an immense prison for every living thing. I have opposed the laws that sustain the murderous State order, both in word and deed. I have tried to be consistent in my position vis-à-vis law and order every time I have been dragged into the dock by the organs of its enforcement, not participating in the hypocritical process of every trial that always pretends to validate the State's control over life and liberty.

I have paid the price of my choices by spending almost 8 years of my life inside penitentiary institutions, which are the centre of the social panopticon, the fear to discipline society and the tool for the reproduction of crime in terms of integration into the dark capitalist economy. Where in the name of the Law the walls suffer a generalized injustice. There in the grey zone of the law where the bones and souls of people are smashed to be thrown away morally and economically broken with no choice but to feed the prison monster with their despair. Providing the perfect alibi for the supposed necessity of the law and the building of the State of society. Of course, the outrages, which, if revealed, are labeled isolated incidents, are actually structural elements of the system and take place under the control or supervision of various officials and servants of the State, the «corrupt» and those who passively tolerate them so as not to jeopardize their positions or careers.

And all this for the judicial elite is arithmetic: mechanically counting days, months, years of imprisonment without being aware of
